Expression of interest

Detailed submission

If your EOI is successful, the office of IECA Australasia will invite you to submit a detailed entry of your EOI. Following is the information you will need to include.

Please note, entries will be judged on the following criteria, as applicable to the selected Award category and the respective weighting allocated:

- 1. Completeness and clarity Weighting of 5%
- Demonstrated success of entry in improving land, air or water quality through the application of erosion and sediment control technologies and/or programs - Weighting of 10%
- 3. Use of innovative approaches that maximise performance Weighting of 20%.
- 4. Description of methodology, scientific design, and effectiveness Weighting of 5%.
- Demonstration of tangible and quantifiable improvements in cost control while reducing off site effects as a result of the practices implemented - Weighting of 30%
- Ability of entry to serve as a model for similar efforts and outline a potential strategy to ensure successful implementation - Weighting of 20%.
- Contribution of individual, organisation or technological development to the advancement of the erosion control industry - Weighting of 10%.

Section 1

A marketing statement of no more than 200 words outlining the submission that can be used for media releases and award publications

Section 2

Summarise the entry description in abstract form with a maximum of 400 words (1 page).

Section 3

Describe the location, beginning, respective milestones and completion dates (as applicable) for the entry. List the major parties involved with the entry. Summarise the sequence and dates of activities.

Section 4

Describe the distinctive features, special accomplishments, difficult challenges and other unique aspects of the entry. Include a Microsoft PowerPoint presentation with between 10 and 20 pictures along with written descriptions of each picture to illustrate the entry. These pictures may be used for media and promotional use. PowerPoint presentations must be submitted on USB or emailed to admin@austieca.com.au. A PowerPoint presentation must be submitted with each entry. Include 3 good quality pictures that could be used for promotional purposes.

Section 5

Describe the quantifiable benefits the entry has contributed to the environment, the community and the erosion control industry and your company/organisation.

Section 6

Name and describe the person(s) who would receive the award. Include company/affiliation, mailing address, phone, and e-mail.

Section 7

List three referees who were directly involved with the entry. Please include name, company/affiliation, address, phone, e-mail and their position or role associated with the entry.
